### Information on the membership of KidsLife Brussels

- KidsLife Brussels asbl informs you that you are connected for a minimum of 24 months. After the first day following the 24th month of connection, you may change your connection (Article 26, § 2 of the ordinance of April 4, 2019 establishing the payment circuit);
- KidsLife Brussels asbl informs you that the decision to change your connection will take effect on the first day of the quarter following the quarter in which the request was sent, unless that request was made during the last fifteen calendar days of a quarter. In that case, the application will only take effect from the first day of the second quarter following that of the application (Article 26, § 2, second paragraph of the Order of 4 April 2019 establishing the payment circuit),
- KidsLife Brussels asbl undertakes not to refuse the application for affiliation of a recipient of benefits, except in the cases provided for by law, nor to oppose his/her decision to change institutions (article 4, paragraph 1, 9° of the ordinance of 4 April 2019 establishing the payment circuit);
- In no case may the connection lead to benefits other than those determined by the regulations (Article 31 of the Order of April 4, 2019 establishing the payment circuit).
- For customers already receiving child benefit from KidsLife, the initial affiliation application remains valid. No new mandatory affiliation period starts.

The details that you supply on this form are collated to determine your entitlement to the Growth Package and its subsequent payment. The information that you provide is protected by the Personal Data Processing Act of 8 December 1992. Please contact the above address for the inspection or correction of your data.
